# TERMS AND CONDITIONS

- c. By receiving ticket from Suzuki and entering facility, you have assumed all responsibility of yourself and the events that take place during your attendance.

### 5. <u>Limited Entries</u>.

- a. Spots are limited and will be filled on a first come, first served basis.
- 6. <u>Admittance</u>. Suzuki reserves the right to refuse an entry ticket or meal voucher to anyone at any time for any reason solely based off Suzuki and its staff's discretion.
- 7. <u>Image/Likeness</u>. By participating in the event, you grant Suzuki and its affiliates a perpetual rights license to use your likeness without limitation and without separate compensation.
- 8. <u>Attorney's Fees</u>. If a lawsuit is brought in any dispute or cause of action relating to this event, Suzuki will be entitled to reasonable attorney's fees compensation.
