Limited Entries.

- a. Spots are limited and will be filled in order of registration form submissions.
- b. Registrants who have already attended a prior event will be set as alternates unless entry cap is not met.

<u>Admittance</u>. Suzuki reserves the right to refuse admittance or expel from event any Participant Suzuki determines is behaving in a manner of disrupting the event or posing danger to other participants.

<u>Image/Likeness</u>. By participating in the event, you grant Suzuki a perpetual rights license to use your likeness without limitation and without separate compensation
